Terms and Conditions

Fees

1. Registration fee of \$25.00 is due to hold the students spot in lesson or class and is non refundable
2. Tuition fees are payable before classes or lessons begin either in full by Cash, Cheque, Etransfer or 4 payments or 9 payments by postdated cheques or etransfers on the 1st-15th of each month September to May of given year.
3. All Students that are returning for the new school year there is \$125.00 deposit required with paperwork by June 30th of that year. If the student withdraws after August 15th of that year the 125.00 is non refundable.
4. A purchase of a school Tshirt of \$20.00 is required by each student in a group class.
5. If payment other than registration fee is requested to be paid by credit card an invoice will be issued through Paypal. Payment will be made in full or by 2 payments September and January and a convenience fee is charged.
6. Payments can be made by mailing to EJS School of Fine Arts # 105a 14772-64 Avenue Surrey BC V3S 1X7
7. In person payment can be arranged by appointment with the Executive Director
8. Invoices must be paid prior to the start of classes or lessons whenever the student begins whenever the student enrolls throughout the year.
9. Payments can be made by Cash, Personal Cheques, E transfer to ejsfinearts@hotmail.com or by Paypal.
10. Convenience charge will be added to payment through Paypal
11. A \$25.00 fee will be charged on all returned cheques

12. Students in Dance, Musical Theatre and It's Show Time classes required dance shoes which can be purchased directly from Limbers or Avalon Dance Shop in Delta. Please mention EJS when purchasing.

Register, Attendance and Absence

1. Under no circumstances should students attend class with any kind of illness.
2. Masks are recommended but will be required by some teachers or departments.
3. Attendance for each class is maintained by teacher and records of students attendance for the purpose of safety, health and security.
4. Consistent regular attendance is required by every student but if the student is going to be absent you need to contact the school either by phone at 604 596 4883 or 604 543 1377 or email at ejsfinearts@hotmail.com.
5. If a student misses a class or lesson due to sickness or any other reason the class or lesson is not made up.
6. A zoom class is offered if notification to the school office by 8:00am for a Saturday morning class or 12:00 noon for an afternoon class if available.
7. If a student is doing their classes online and forgets or for some other reason misses their lesson or class the lesson or class is not made up.
8. Our fees are based on 32 instructional days and each student is scheduled from September to June to receive the 32 lessons or classes.
9. A zoom class is only available for the purposes of missed classes due to illness not vacation, holidays or other activities.
10. If due to sickness of a music teacher we will do everything we can to either do the lessons online or to reschedule the lessons. This applies to the Music Dept. only. There are no refund given.
11. If a student will be absent due to various reason. eg. travel if the spot is not paid during the absence the spot will be available to be filled by

another student. When the student returns we will do our best to find them a spot with the same teacher if possible.

12. If a script is damaged, destroyed or lost a fee of \$20.00 will be charged

Late Payment, Right To Attend, Change Classes, Withdrawal and Termination of Attendance

1. The payer will receive both verbal and written notice if payment has not been received in accordance with these terms and conditions for any invoice.
2. The school reserves the right to charge a late payment fee if an invoice remains unpaid after the first class of a new term and withhold participation of the student in a class or lesson until payments are made.
3. If an invoice has not been paid at the start of the school year or upon enrolment, the student will not be admitted to any classes or lessons until the invoice has been paid in full.
4. The School reserves the right at any time during the school year to ask a student to leave a class or lesson if any fees remain outstanding after the start of classes.
5. Students registered in any lesson or class after September 1st a one month's written notice to withdraw from classes and as of October 1st the account will be balanced.
6. Students registered in all lessons or classes that withdraw after October 1st or their first month, we require one month's written notice to withdraw from classes. After that month the balance of student's instructional day will be calculated and the balance owing will be refunded
7. Extenuating circumstances of withdrawals are dealt by the Board of Directors.
8. Private Music Lessons required a one month's written notice to withdraw from lessons after September 1st. After that month then the balance of the students instructional days will be calculated and the balance owing will be refunded.

9. If a student withdraws from a lesson or class and the refund is issued the parent or guardian have 6 months from the date of the refund cheque to claim the refund after that the payment will not be reissued.
10. No refunds are given for withdrawal from lessons or classes after April 30th of any year.
11. Each musical theatre and dance student are required to sell or purchase 6 tickets for each show they are part of.
12. Any students from Dance or It's Showtime that perform in a theatre production are required to sell or purchase 6 tickets.

Discounts

1. Where there are 3 or more siblings attending group classes the youngest sibling will receive a 3% discount on their classes
2. No discounts are given on private lessons
3. Performance series discounts are calculated by the classes taken
4. Special family discounts are at the decision of the Board of Directors

Bright Star Program/Sponsorship Program

1. Students accepted in our Bright Stars or Sponsorship programs are required to have regular attendance to classes
2. Students are to pay required registration fee depending on which program they are accepted in.
3. If students are in Musical Theatre or Dance they are required to purchase or sell 6 tickets to each show they participate in unless otherwise arranged through the school office.
4. If students are in Art classes they are required to purchase 4 tickets to their Art Gallery Moments.
5. At the end of each school year the students need to reply to either program to see if funding is available.
